Utilizes the agency's computer system to input complete and accurate case information. Extracts and accurately interprets information regarding both case demographics and case work. Updates client information in the computer as necessary.
- Prepares reports, statistical data, and detailed correspondence and legal documents. Proofs copies for accuracy and makes corrections. Files motions, complaints, pleadings, affidavits and other legal documents or actions with local Courts.
- Works with CSEA Staff and related agencies, offices, courts, and other organizations in a respectful, cooperative and efficient manner in order to provide a high level of service to the agency's clients.
- Attends and participates in all mandatory meetings, training sessions, or classes.
- Preserves and protects the confidential nature of any information maintained by the agency.
